 - ii. Architect Selected Cushman Design
 - iii. 1st Mtg held 2/26 BEC Invited
 - 1) Matt Spoke, Bob chimed in
 - 2) Kevin Harper also supported efficiency in the design
 - 3) Architect has worked with EVT before & designed energy efficient new buildings
 - 4) Matt to take the lead
 - 5) Next mtg is Mar 5
 - 6) Objective: Convince committee, Select Board, and voters that up front additional costs to build an efficient building will pay back big time
 - 7) Action: Matt & Bob continue to attend Design Committee Meetings
 - b. Bristol Water System Pumps (3) (water from river to water tower)

 - c. Solar Lighting on Pathway from Liberty St to Mt Abe

 - 2) 1 every 50 feet
 - 3) Dimmable after a period of time

 - 5) Light directed down, not into homes

 - iii. Process
 - 1) Demonstrate the feasibility (estimated business case)

 - ii. Much better payback than when first looked at a couple yrs ago

 - 2) Provide ANESU/Mt Abe with the info they need to put out an RFP

- e. Lighting/solar at Rec Field
 - i. Dave has been approached about lighting and solar PV at the REC field
 - ii. Objective is to reduce the cost of the lighting so that more groups can afford to use the field after dark
 - iii. Process
 - 1) Demonstrate feasibility (estimated business case)
 - 2) Provide ANESU/Mt Abe with the info they need to put out an RFP
 - iv. Action: Review with Rec Dept decision makers when ready Dave
