      - There are provisions going forward in the VT Legislature (H40) that would encourage solar on closed landfills
      - A similar solar farm was built in Rutland

 John agreed to contact Caroline Camara (Teacher advisor of the Environmental Club) to propose it as a student led project with BEC advisors
