

## 2019 Town Meeting Day Notes

### Addison County Solid Waste Management District

#### ABOUT US

**History.** The Addison County Solid Waste Management District is a union municipal district formed in November 1988 to cooperatively and comprehensively address the solid waste management interests of its member municipalities: Addison, Bridport, Bristol, Cornwall, Ferrisburgh, Goshen, Leicester, Lincoln, Middlebury, Monkton, New Haven, Orwell, Panton, Ripton, Shoreham, Starksboro, Vergennes, Waltham, Weybridge, and Whiting. The District charter, adopted by the VT Legislature, establishes the authority and powers of the District. District population is now 36,719, and area is 698 sq. miles.

#### District Mission Statement

"The Addison County Solid Waste Management District is a union municipality that exists to cooperatively and comprehensively address the solid waste management interests of its member municipalities. The mission of the District is to:

- ♦ promote waste reduction and pollution prevention;
- ♦ maximize diversion of wastes through reuse, recycling, and composting;
- ♦ provide for the disposal of remaining wastes; and
- ♦ seek environmentally sound and cost-effective solutions in all of its programs, services, and facilities."

**Board of Supervisors.** The District is governed by a Board of Supervisors composed of one representative from each of the 20 member municipalities. Board representatives and alternates are appointed by the legislative bodies of the member towns for a term of one year, after Town Meeting Day and prior to the Board's Annual Organizational Meeting on the second Thursday in April. Anyone interested in serving on the Board is encouraged to contact his/her selectboard to express interest in the position. There is no limit to the number of successive terms that can be served.

**Meetings.** The Board regularly meets on the third Thursday of the month at 7 PM in the conference room of the Addison County Regional Planning Commission, 14 Seminary Street, Middlebury. The Executive Board meets monthly, eight days prior to the monthly Board meetings (usually on the second Wed.), at 3PM at the ACSWMD office at 1223 Rt. 7 South, Middlebury. All Board meetings are open to the public.

## MATERIALS MANAGEMENT PLAN

All VT solid waste planning entities (districts, alliances and independent towns) must comply with a State Materials Management (Solid Waste) Plan (MMP), which is amended every five years. The Board adopted a new Solid Waste Implementation Plan (SWIP) in July 2015 (amended in 2018) to conform to the new Universal Recycling Law (Act 148) and the 2014 State MMP. The State MMP incorporates a sustainability vision containing new performance standards, including those focused on implementing Act 148. The main goal of the MMP is to reduce the disposal rate of Municipal Solid Waste (MSW) in Vermont by 25% from 413,517 tons to 306,772 tons by the end of the MMP term. The per capita disposal rate of MSW is to be reduced from 3.62 lbs/person/day to 2.69 lbs/person/day (50% diversion rate). The District's 2017 SWIP Report shows a 2016 MSW disposal rate of **2.00 lbs/person/day** and a 2016 MSW diversion rate of **55.30%**, or **2.48 lbs/person/day**. The District has exceeded the State goal of 50% diversion from 2006-2017. Staff will be preparing a new SWIP Report by July 1, calculating 2018 disposal/ diversion rates.

## 2019 ANNUAL BUDGET

- **2019 Annual Budget Total:** The 2019 Annual Budget is \$3,223,095. This represents a 7.69% increase from the 2018 annual budget.
- **2019 Rates:** The Transfer Station tip fees will increase to \$126/ton for MSW and C&D. This is the first rate increase since 2011. The rate for Single Stream Recyclables will increase to \$92/ton, due to higher recycling costs, and self-haul businesses will now have to pay for recycling. Rates on some other items will have nominal increases. New fees: \$1 per visit or per 50 or < lbs of household goods at the *Reuse It or Lose It!* Shed; and \$5/load for books. There are **no assessments** to member municipalities in 2019. The 2019 Adopted Rate Sheet is attached.
- **2019 District Fee:** Our District Fee remains at \$33.40/ton on all MSW/ C&D generated in member towns and destined for disposal, and \$10/ton for soils approved by the VT Agency of Natural Resources (ANR) for use as alternative daily cover at the landfill. The \$33.40/ton is included in the \$126/ton tip fee at the Transfer Station. Other districts have been steadily increasing their MSW/C&D surcharges while ours has remained the same **since 1999**.
- **Diversion Grants:** In order to assist member municipalities and schools to establish recycling/ composting programs, the District created Diversion Grants for each – a 50% match for municipalities and a 75% match for schools. An application is available on our website.

## DISPOSAL SYSTEM

- Commercial haulers provide curbside waste collection in all District member towns except for Goshen, which provides the collection service. The MSW/C&D is hauled to the District Transfer Station in Middlebury, where the waste is loaded into transfer trailers for long haul to the Casella Waste Management (CWM) N.E.W.S. Lined Landfill in Coventry, VT, currently the only operating lined landfill in VT. CWM subcontracts with MBI for the hauling of our MSW/C&D using MBI trailers. The Transfer Station accepts waste and recyclables from licensed commercial haulers. All commercial haulers must have a VT Waste Transporter Permit and be licensed by the District. Households may bring large loads of “clean-out” waste and other special wastes that are not picked up at the curb, but the Host Community Agreement prohibits us from accepting small bags of household-type garbage and recyclables from residents. Those bagged MSW/ Mandated Recyclables are collected either at the curb or at one of the 16 town drop-offs or private “bag-drop” trash trucks in the District.
- The HazWaste Center at the Transfer Station is open year-round, six days/week: Mon – Fri, 8 AM – 2 PM, and Sat, 8 AM – 1 PM for residents, and by appointment on weekdays for conditionally-exempt generator (CEG) businesses. Household hazardous waste (HHW) is accepted at no charge from District residents. CEG waste is accepted for the cost of disposal plus a \$5/fee. HHW/CEG hazardous wastes are subsidized by the per-ton fees we charge for MSW/C&D, so only member towns are allowed to use the facility.



## RECYCLING SYSTEM

Act 148 and the District's Waste Management Ordinance (WMO) require the recycling of the following "Mandated Recyclables" that are banned from the landfill:

- Glass bottles & jars from foods & beverages
- High density polyethylene (HDPE) plastic bottles & jugs
- Polyethylene terephthalate (PET) plastic bottles or jugs
- Boxboard
- Corrugated cardboard
- Magazines & catalogues
- Aluminum & steel cans
- Aluminum foil & aluminum pie plates
- Paper bags
- Paper mail & envelopes
- Newspaper
- White & colored paper

As of 7/1/15, all facilities/ haulers had to offer collection of Mandated Recyclables. Haulers and facilities are required to imbed the cost of **residential** recycling in the trash bag fee, with the following exceptions: (1) Commercial haulers may charge a stop fee for curbside service; and (2) commercial haulers with parked trucks may charge for recyclables if the customer does not bring trash with it, or if the volume of recyclables is too much for the trash fee to cover. The recycling system in the District is "single stream", i.e., all Mandated Recyclables are mixed together in one container. The recyclables are hauled by CWM in our own trailers to its Rutland Material Recovery Facility (MRF) to be sorted mechanically and by hand. Haulers may accept other materials beyond those included in the Mandated Recyclables list above, such as #1-7 plastic containers. All of the 20 member towns have access to a recycling drop-off via: (a) a town drop-off; or (b) a hauler parked on private or town land. Attached are information sheets for two of our newest recycling programs at the District Transfer Station: maple tubing and film plastics.

## VERMONT PRODUCT STEWARDSHIP PROGRAMS

Extended Producer Responsibility (EPR) laws are a useful tool to help distribute the cost of recycling and safe management of these products between industry, government and consumers. EPR can alleviate the financial burden for municipalities and residents, while mitigating environmental impacts from disposal by increasing collection and recycling rates of covered products. Vermont's EPR programs remain effective at collecting targeted materials, largely due to education and collection efforts by the State and solid waste districts. VT has the second highest number of EPR laws in the U.S. and has recently led the way with a law on primary cell batteries. These efforts are coordinated through the VT Product Stewardship Council, of which the District is a member, and which recently celebrated its tenth year of success in establishing EPR laws in VT. The District Transfer Station is a registered collector for all of these programs.

## ACT 148

The VT Legislature unanimously adopted Act 148 - the Universal Recycling Law – in 2012. The following chart summarizes Act 148 deadlines and the status of each. As described in VT ANR's Biennial Report, several haulers have continued to ask for changes to Act 148, particularly with respect to curbside organics collection, which they see as an economic burden in low-density areas.

*\*Note that mobile drop-offs may collect leaf & yard debris in a container on the ground without needing a certification if they collect <3,000 cu.yds/yr. of leaf & yard debris, provided that not more than 20% of the residuals are grass clippings. Certified facilities may add leaf & yard waste collection without having to amend their certifications if they collect <3,000 cu.yds/yr. The 7/1/16 ban also includes clean wood (brush). Facilities in the District towns do not have to offer collection of clean wood, because a central collection site is available at the District Transfer Station.*

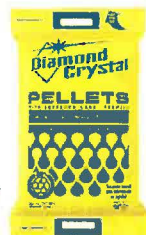

## What's accepted:

- Polyethylene (PE) sap line



## Not accepted:

- PVC sap line or pipe
- Teflon-lined sap line
- Drain, sewer, or water pipe
- Metal/strapping/tension wire
- Leaves, dirt, rocks

Not sure if you have polyethylene? If a small piece floats in water, it's polyethylene.



## What you need to do:

- Cut stiff main line into 3-foot lengths
- Remove tees, taps & fittings (or pay a fee)
- Make an appointment to drop it off at the ACSWMD Transfer Station by calling 802-388-2333

***Loads that are extremely dirty or contaminated with unacceptable materials may be rejected***



## Fees:

- Loads with fittings removed: FREE
- Loads with fittings still attached: \$20/CY

\*\* VT Mercury Lamp Law -- No charge for general purpose mercury bulbs, 10 or </per day.





\*\*\* VT Paint Law -- No charge for architectural paint. The \$5-per-visit admin. Fee will be waived on paint-only loads.
