Generally, per 24 VSA 1931(b), the police chief is vested with direction and control of the entire police force except as otherwise provided. https://legislature.vermont.gov/statutes/section/24/055/01931

Valerie,

The draft you sent appears to be an exact copy of our model policy. This has been vetted and meets the legislative requirements. I certainly recommend this as the policy for VT police departments.

As far as the procedural question, I do not know of any legal mandate for policies to be adopted or reviewed by the legislative body. As chief in two cities I did not follow this process. However, it could be good practice for the body to be aware of policies and to be certain they meet, or in some cases, exceed, existing Town policies. I am aware that some jurisdictions have the board approve and/or review the police policies. If the Town does move to have polices reviewed or approved by the Board I would caution that some components of them may be elements that would be unwise or unsafe to have be made public. The VT Public Records Act does provide an exemption for some law enforcement records under 1§317 (c)(5)(A)(v) [would disclose techniques and procedures for law enforcement investigations or prosecutions, or would disclose guidelines for law enforcement investigations or prosecution if such disclosure could reasonably be expected to risk circumvention of the law].

**In the interest of you receiving sound legal guidance I have copied Abbey Friedman from our Municipal Assistance Center. I am sure a member of the MAC team can weigh in as well.
