- B. The email dated 28 Jan 20 from KU regarding the history of the CRF mentioned that the CRF has been used to leverage grants for town-owned properties (e.g. South Street Coffin Factory and River Bend Trails, and the Memorial Forest Park design).

- B. Bristol Trail Network (BTN) update: PK is applying for a grant to install benches along the BTN
- C. Parks Updates: Eagle, Memorial, Sycamore, PK mentioned the late May availability of a Middlebury pedistrian bridge for Memorial Park. The proposed bridge will be located upstream of the existing bridge. Sycamore Park needs to have its trail network cleared of debris and knotweed. The repair of the universal fishing platform is being investigated. Alex Mihovics (Ass't Rec Dir) and Genaro Valant (intern) expressed interest in working with the BCC on student projects. The consensus of the BCC was to be supportive and interactive with the Parks and Recreation Department.
- D. Town of Bristol resources: Disseminating information regarding town natural and cultural resources: PK is working on a grant (Vt. Outdoor Recreation Economic Collaborative) to increase recreational information and opportunities in Bristol.
