#### **II. Scheduled Appointments**

A. Mike & Debra Brown, Sodbusters – New England Tournament – It's been the largest horseshoe tournament in New England. The tournament been in Keene, NH for the 22 years. Bristol received the bid to host this year. The tournament has brought in \$50-80,000 in past years for amenities. Will be held in September. First time Vermont has hosted since 1992 in Bennington. Making adjustments to be able to have more courts. Sept 4<sup>th</sup> – Fun Night to get started with some festivities. Sept 5th- official start at 8 AM; Legion will host a BBQ. Sept 6<sup>th</sup> – Tournaments will continue. T-shirts will be made and likely incorporate the Tower design. CORE offers to make some Bristol Bucks available for the Silent Auction. Maybe CORE would like to sponsor a banner or perhaps a court? Every member should have a sanctioned card. Think about potential for a "welcome packet" with a map of downtown, village, and larger region. The Hub is offering space and some low-key programming with movies, outside games, and arts/crafts. Potential for exploring opportunity for "drinking bus" from Legion. Mike is looking for lodging options (Mike will email the existing list). 10 days before the tournament will have the entry numbers. Meridith suggests "Ringer Oil" idea for Bobcat or Hogback.
