Valerie,

Thank you for your time.

Attached is the quote we have received for purchasing AED's (Automated external defibrillator) for Bristol Rescue.

As we discussed I would recommend that the Town consider having an AED available at the Police Station that could be taken out on patrol, or in a best case scenario one mounted at the Station, and one available for in the cruiser.

The units we have chosen are automatic so minimum training required for use (basic CPR class covers).

Know you planned to check to see if Town/Holley Hall has an AED in place. If not, certainly something to consider.

We have CPR and Stop the Bleed trainers and classes available.

If you would like to schedule a class just let me know and we can discuss possible next steps.

Understood that you next Select Board meeting is later in the month.

We can hold on ordering until after your meeting. Our pricing is based on quantity and may be possible to obtain additional discount if looking at additional units.

Based on current quote each unit would be \$1,233.50.

Pricing is already very good, and is based on an order I placed last year.
