Hi Valerie,

In the 40 plus years I've owned this property, I've only asked the Town to help with the fence a few times, most recently when their plowing pushed in over. The Town Manager at the time had the town crew fix it and that was that.

I installed the current fence and the two before this one, maintained them, painted them and never asked the Town to contribute. The reason that I'm asking for a contribution this time is because the snow and ice falling from the roof is what caused the damage to it this past winter.

I've gotten one estimate which is for \$500 to reinstall the posts that are broken and replace the portions of the fence that were broken.

The estimate is for the picket fence only. The stockade fence is a different matter and a different number, a much larger one.

I am asking that the Town pay half of the cost to repair what has been damaged.
