Hi

Attached are the PreBuy sheets for propane from Jackmans this year. There are no credits this year as we received a refund check the end of June.

The refunds were minor except for the Fire Dept which received a refund of \$1,310.64 as they did not use as much as expected. We estimated 2800 gallons last year and only used 2032. Jackman's is suggesting 2400 gallons for this year which drops it down 400 gallons from last year. **Brett – do you agree with the decrease?**

The HUB had a sizeable refund as well (\$520.62). We estimated 564 gallons and they only used 275. Jackman's is suggesting 350 for this season. **Taylor – do you agree with the decrease?** (COVID probably paid a role in the drop as well).

The only department that went over last year's PreBuy is DPW. They were over by approximately \$200. Estimate was 1500 gallons last year and they used 1603. Jackman's is suggesting 1650 gallons. **Eric – do you agree with the increase?**

Valerie – below is the PreBuy gallons we had last year, the amount used and the suggested amounts for this year.
