Good Morning Ian,

Once we hit commissioning, I will submit the credit allocations to the utility based on the percentages in exhibit C of your NMA. No need to take any action there, but I will confirm with the town administrator when this happens. Would you like to be copied?

After solar credits are allocated, your GMP bills will synch up with the generation period of our Bristol South GLC Solar project. This may mean that you start receiving bills at a different time of the month. We put together our Solar Invoices based on 90% of the credits that show up on your GMP bills. The remaining 10% is your savings which will also be noted on our Invoice. According to the NMA I will be sending these monthly Solar Invoices to the Town Admin email address (Cc'd). Is that Valerie? Is there anyone else that should be receiving the Solar Invoices?
