This is the quote from Pike to fix the paving on 116 in front of the squirrels nest and to patch in front of Pam's house on the corner of Mountain and Pine.

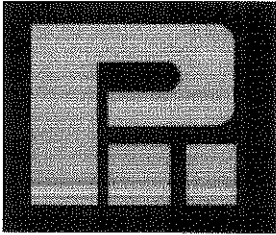
Please let me know if we can give them the go to get these final pavement patches done to clean up the last of the 2020 waterline repairs with pavement needed.
