

#### **Broadband Survey Assistance Needed**

September 2020

Due to the COVID-19 Emergency, the need for quality internet access at homes to support children's educational needs, medical care, or work from home has significantly increased. In response, the State has committed over \$17 million dollars to bring expanded broadband access to communities without adequate service. The Vermont Department of Public Service is collecting information to see what can be done to help more residents get better internet at their homes.

DPS has created an interactive map that allows users to view reported broadband speed information for all addresses, along with an integrated survey with simple questions about K-12 students, Telehealth, and Telework needs. Please take the survey for your address and help us distribute the information to other community residents.

# **ACRPC Staff Updates**

Kevin Behm, Asst Director & GIS Data Manager Kevin has been busy with office upgrades over the past month in addition to a municipal mapping projects. Recently he has been negotiating a lease for a new office copier. The existing Canon copier has served us well and it will be replaced with an updated Canon at a slightly lower cost per copy. He has continued reviewing operating requirements for a more modern website with easier to use plug-ins for uploading and organizing reports, documents and other media types as well as meeting ADA requirements. Also, in preparation for a new ECO AmeriCorps service member due to arrive in September we purchased an office laptop and loaded all the necessary software and configurations necessary for her to operate remotely and login to the office.

#### Katie Raycroft-Meyer, Community Planner

Katie is working with Salisbury in applying for a Municipal Planning Grant (MPG). The Planning Commission wants to continue updating their Town Plan by developing a Forest Fragmentation section to incorporate into the Natural Resources and Land Use chapters. MPGs are due Oct 1<sup>st</sup>, so there is still time to put an application together.

Both Vergennes and Panton are scheduled to have their municipal plans and **Enhanced Energy Plans**, regionally reviewed. Once approved, there will be six communities in ACRPC region that have completed this effort.

As the Ferrisburgh Planning Commission works to update its zoning, Katie has been working with a sub-committee to conceive of mix-use, design scenarios that would support compact development and increased housing opportunities in the town. This project is a continuation of a MPG, **Visualizing Density**, that Ferrisburgh received in 2020. To illustrate these concepts, graphic examples of possible scenarios will be generated and shared with the community.

#### Mike Winslow, Transportation Planner

Mike is working with the Town of New Haven to develop a grant application for a Scoping Study to widen Munger St. to better accommodate bike traffic. The project is a direct outcome of the recently completed Triangle Bike Loop Master Plan. TAC funded planning studies are nearing completion for Bristol and Salisbury. Mike has been working on a few major projects that are in the early development stages. First, VTrans has approved a Planning and Environmental Linkages Study for the Vergennes Economic Corridor. ACRPC and VTrans are in discussion about developing an Advisory Committee and a Technical Committee for that project. Second, ACRPC has been involved in discussions about DEC's rule-making for Clean Water Service Providers for the Otter Creek Basin and other watersheds around Vermont. Grants in Aid projects are slowly being completed. As of this writing, 9 projects have been completed and inspected, 1 additional project is scheduled for inspection, 2 towns have cancelled projects for FY20, and 9 towns still need to wrap up their work and schedule a post -construction site visit before October 15.

#### Andrew L'Roe, Emergency Management Planner

Andrew has been working with community EMDs and town officials to begin recovery from COVID-19 and prepare for additional challenges due to the pandemic or other hazards. He is working with towns to apply for Local Government Expense Reimbursement (LGER) Grants and organizing events for the Local Emergency Planning Committee (LEPC), Emergency Management Directors. Working with Katie he is finishing up updates to the Bristol Town Plan with the Planning Commission. Finally, Andrew is working with Energy Committees to organize Button Up Energy events in October.

# Chainsaw Safety Trainings Game of Logging

The Watershed Center, 4783 Plank Rd, Bristol VT Vermont Family Forests is hosting these one-day courses (8am-4pm):

• Basic Chainsaw Use & Safety, 9/15

This course is designed to introduce the safe handling of the chainsaw as well as boosting the confidence level of anyone who has very little or no experience with a chainsaw.

- Level 1: Precision Felling Techniques, 9/17 This workshop introduces open-face felling and the development of techniques to safely use it. Topics covered include personal protective equipment, chainsaw safety features, chainsaw reactive forces, bore cutting, pre-planning the fell, and understanding hinge wood strength.
- Level 2. Maximizing Saw Performance, 9/24 This workshop focuses on maximizing chainsaw performance through basic maintenance, carburetor setting, and filing techniques. Limbing and bucking techniques are introduced, spring pole cutting is covered and more felling is practiced.

• Level 3. Limbing, Bucking, & Difficult Trees, 10/1 This workshop training includes dealing with lean when felling trees; limbing and bucking downed trees; felling difficult and hung-up trees

There is financial assistance available from the Local Emergency Planning Committee (LEPC 8) for municipal road and public works employees to take part in this training.

## Ash Tree Management Grants

#### Applications due October 30, 2020

The Urban & Community Forestry Program announces a new grant opportunity to support municipalities ready to engage in ash tree management. Applications are for cost-share grant funds between \$5,000 and \$15,000 that will support projects in at least one of the following categories:



• Removal of ash trees on municipally owned or managed land and replacement plantings of species other than ash.

• Development and implementation of effective and/or innovative management techniques and use of ash wood from public trees.

• Assessment, management planning, and active management of ash trees in high-use municipal areas such as parking areas, trailheads, and along trails in town forests or natural areas.

Due to budget constraints, it is very unlikely that Vermont UCF will sponsor any other grant programs in 2021, including the Caring for Canopy grants that have historically supported local tree management programs.

# **FEMA Mitigation Funding Programs**

## **Building Resilient Infrastructure**

#### and Communities (BRIC):

[replaces what was previously the Pre-Disaster Mitigation (PDM) grant program]

• Eligible Applicants: State agencies, Regional Planning Commissions and municipalities. Note: Municipalities must have an approved Local Hazard Mitigation Plan at the time of application submittal.

• Eligible Projects: Everything that was previously eligible under PDM will still be eligible, e.g. home buyouts, culvert projects, Local Hazard Mitigation Planning grants, etc. In addition, under BRIC, applicants can apply for:

• Project Scoping (previously Advanced Assistance)

- •Capability- and capacity-building activities
- •Non-financial direct technical assistance

**Management Costs:** 5% of total project costs will be available to sub-applicants for managing the grant award.

**Cost Share:** 75% federal, 25% local non-federal (cash and/or in-kind); up to 90% federal share for small, impoverished communities.

## Flood Mitigation Assistance (FMA):

FMA funds must benefit an NFIPparticipating community; ideally those with Repetitive Loss/Severe Repetitive Loss properties

• Up to **\$600,000** is available per State for **Project Scoping** to develop community flood mitigation projects that reduce future NFIP flood claims.

• Up to **\$30 million** can be applied for per sub-applicant for **Community Flood Mitiga-tion Projects** to address community flood risk to reduce future NFIP flood claims.

**Cost Share:** 75% federal, 25% local nonfederal (cash and/or in-kind); or up to 90% for Repetitive-Loss and up to 100% for Severe -Repetitive Loss properties.

# Climate and Energy Resource Guide https://climateenergyguidevt.org/

Acorn Energy Co-op (Acorn) and the Climate Economy Action Center of Addison County (CEAC) have developed an online guide offering free listings to local businesses and organizations doing work related to climate and renewable energy in our region. The Climate and Energy Resource Guide is intended to highlight the good work going on in these areas and to make information accessible to consumers and businesses.

## Downtown and Village Center Tax Credits

In July, downtown and village center revitalization initiatives received a big boost from \$3.2 million in state tax credits for 30 projects, supporting over \$160 million in building improvements and public infrastructure. Since 1998, almost 400 projects in more than 75 communities have used more than \$34 million in tax incentives to open new businesses, create new housing opportunities, and add vitality to Vermont's community centers. Projects in Addison County this year include:



**64 Main Street, Middlebury** – This project will restore and preserve a mixeduse building with major improvements along Frog Hollow Alleyway façade. State tax credits will also support code improvements to ensure the building's two apartments are more marketable and remain affordable. Total Project Cost: \$64,693; Tax Credits Awarded: \$18,173



**34 North Street, Vergennes** – In support of an expanding assisted living community, the City of Vergennes will complete several infrastructure projects to better connect the Vergennes Grand Senior Living with the City Green and Main Street. This includes paving, lighting, and stormwater infrastructure improvements. The facility will expand from 10 to 54 units, providing space for up to 78 residents within steps of the Green and the City's many amenities. Total Project Cost: \$21,656,400; Sales Tax Reallocation Awarded: \$181,030
