The Vermont Department of Buildings and General Services (BGS) has issued the notice of funding availability for the "<u>Building Communities</u>" program for FY22. The RDCs of Vermont, including ACEDC, advocated during the legislative session for the increased funding for this valuable program as proposed by Governor Scott. The increased funding was approved!

Note that there is funding for construction and capital improvements in the areas of recreation, human services, and educational facilities. These applications are made by municipalities and other non-profits directly to BGS.

The due date for applications to be filed with BGS is July 31 and grants are announced in the Fall.

On behalf of the 2021 General Assembly and the Department of Buildings and General Services (BGS), it is my great pleasure to notify you that the Building Communities Grants Program has been funded for FY2022 and with increased funding! This program, administered by BGS, includes the following:

- 1) \$300,000.00 Recreational Facilities Grant Program
- 2) \$300,000,00 Regional Economic Development Grant Program
- 3) \$150,000.00 Human Services Facilities Grant Program
- 4) \$150,000.00 Educational Facilities Grant Program

The grants are for construction and capital improvements to support and strengthen Vermont towns and regions. Descriptions and application criteria for all four of these grant programs are available on the Department of Buildings and General Services website: http://www.bgs.vermont.gov/commissioner/building-communities-grants.

Applicants including municipalities, nonprofit agencies, and regional economic development organizations, are all encouraged to apply for these opportunities to fund construction, infrastructure support, and needed projects.

Although the award of the grants is competitive, the application process has been designed to be simple and straightforward. Grant applicants will be awarded funding as determined by a special committee comprised of private citizens, legislative branch members, and executive branch administrative staff appointed by the Governor. Grants will be awarded in the fall of 2021.

Capital projects for human services, health care, and educational opportunities.

## Recreational Facilities Grant Program

Capital costs associated with the development and creation of recreational opportunities.

# Regional Economic Development Grant Program

Capital costs associated with the development of facilities expected to create or retain job opportunities.





# Historic Preservation Grant Program

Competitive 50/50 matching grants to assist municipalities and nonprofit organizations in restoring important historic buildings.

# Historic Barn Preservation Grant Program

Competitive 50/50 matching grants to assist owners, whether public or private, with the repair of historic agricultural buildings.

# Agricultural Fairs Capital Projects Grant Program

Funding appropriated annually to assist fairs throughout the state with 20-year capital improvements to their facilities.

# Cultural Facilities Grant Program

Competitive grant to assist nonprofit organizations and municipalities to improve community facilities providing cultural activities to the public.

# Agricultural Fairs Capital Projects Grant Program

Administered by the Vermont Agency of Agriculture, Food and Markets, this funding is appropriated annually to assist fairs throughout the state with 20-year capital improvements to their facilities. Approved proposals must be completed within 24 months, budgets must include a 15% cash match, and projects must have a 20-year lifespan. Emphasis is placed on leveraging other funds and generating community support for the fair through improvements to the infrastructure.

### **Cultural Facilities Grant Program**

Administered by the Vermont Arts Council, in conjunction with the Vermont Historical Society and the Vermont Division for Historic Preservation, this program awards grants on a competitive basis to nonprofit organizations and municipalities to improve, enhance or expand the capacity of an existing building to provide cultural programming to the public. Example projects include: wiring, heating, safety, accessibility, lighting, and stage improvements; and permanent display panels/exhibit cases or fixed equipment. Grants range from \$1,000-\$30,000 and require a 1:1 match (at least 50% of which must be in cash and up to 50% of which may be in well documented in-kind materials and/or labor).

Administered by the Vermont Division for Historic Preservation, this program offers competitive 50/50 matching grants to assist municipalities and nonprofit organizations in restoring important historic buildings. Annually, grants of up to \$20,000 are awarded to town halls, libraries, churches, historical societies, and community buildings for restoration and repair of roofs, structural elements, windows, foundations, and other historic building elements.

## Historic Barn Preservation Grant Program APPLICATIONS DUE: Early November

Administered by the Vermont Division for Historic Preservation, this program offers competitive 50/50 matching grants to assist owners, whether public or private, with the repair of historic agricultural buildings. Annually, grants of up to \$15,000 are awarded to repair and restore barns, corn cribs, silos, etc. for roofs, structural elements, windows, foundations, cupolas and historic building elements.

Projects must promote financial engagement in either an individual community or recognized community service area. With a 1:1 match, grants of up to \$25,000 are awarded as last gap funding for permitted, shovel-ready projects.
