Thank you for your follow-up e-mail. Attached, FYI, is the Public Displays and Assemblages Ordinance I referenced in my phone message. According to sections 1.2 and 1.3, the the walk-a-thon qualifies as an assembly, but we do not currently have an application process for venues other than the Town parks. In your phone message, you estimated participation by approximately 25 to 50 people. This would fall under the First Class permit category, which would be approved by the Recreation Director (copied). Also copied are Police, Fire, and Public Works department heads for their awareness and opportunity to share any concerns.

Thank you so much for the phone message regarding the procedure for our upcoming walkathon on June 26th. We will be raising money (and awareness) for an Orphanage in Haiti.
