Good Morning,

I met with Eric here this morning, but unfortunately, we are in the dark (no pun intended) as to what area needs to be "lighted" up...

We currently have a 20 LED on Pole 5 (in front of the Town office), a 20 LED on Pole 4 and also on Pole 2. You can see these poles on the map below.

GMP is willing to add more lights to various poles if needed, however I would be concerned about area residents/apartments and having the lights light up their living quarters in the evening. The other option would be to increase the size of the existing lights, which is a possibility, although will have a monthly cost increase to the Town.

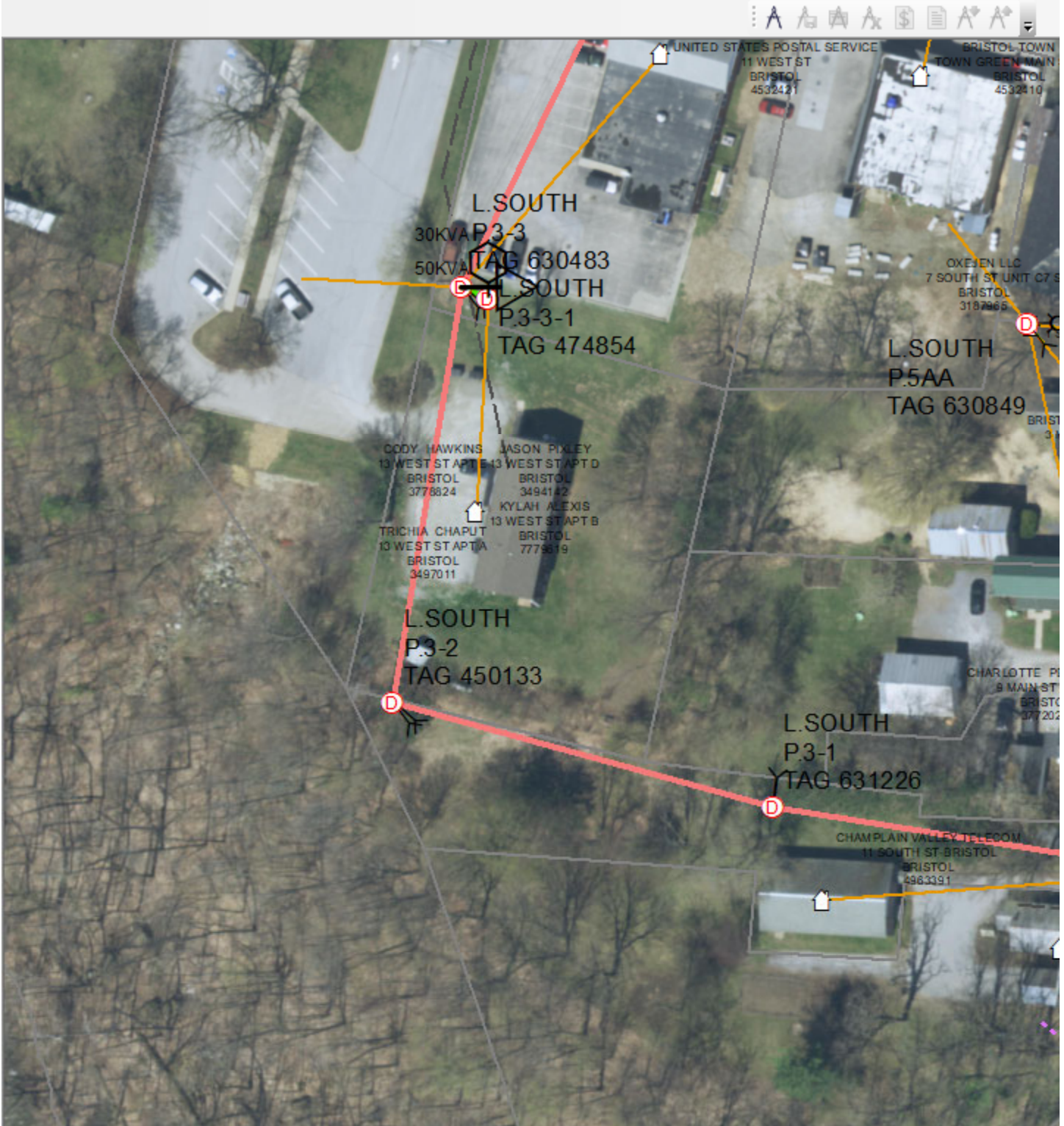
So, basically, GMP is willing to help however we can, but we need more direction to be able to assist you. Thank you.
