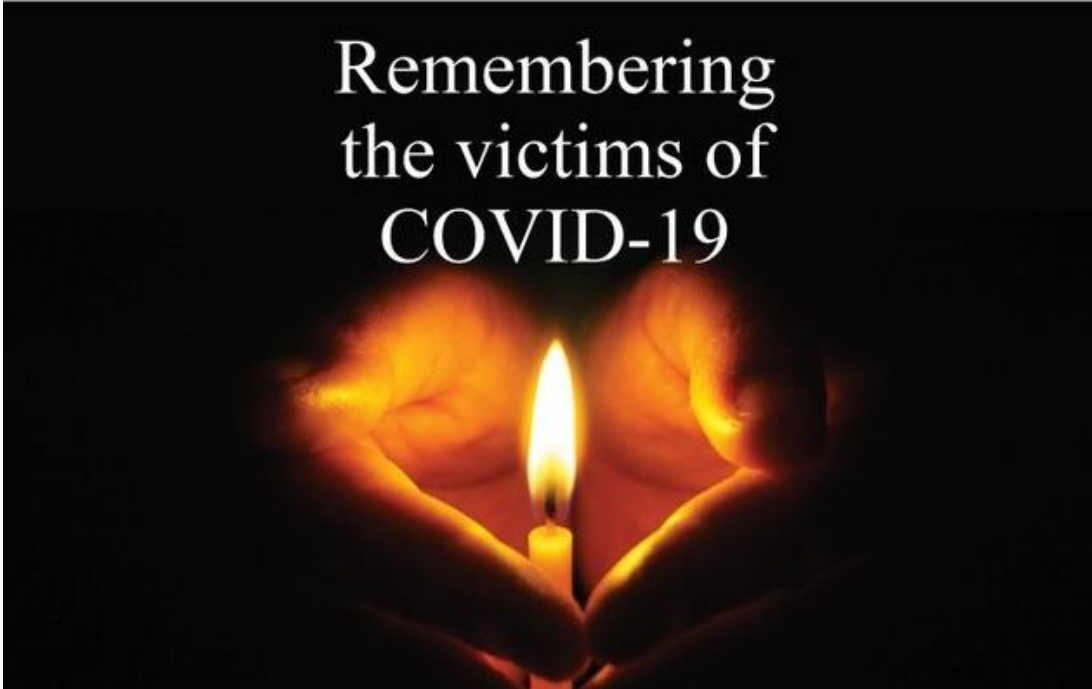
COVID-19 Memorial Planned to Honor Vermonters Lost
