Hello from Maple Broadband, Addison County's Communications Union District. I hope this email finds you safe and well. We hope you will help us update our records following municipal appointments so we can keep our Governing Board current. Every spring we will be asking each municipal clerk to serve as our main point of contact to help us gather information. We truly appreciate your help. Included in this mailing is:

1. **An appointment form for the Maple Broadband Governing Board.** Please complete this form and ask the chair of the Selectboard to sign it. If the Selectboard has not yet made these appointments, please ask them to make the appointments, complete the form, and return it to you, so that you can send a copy to me no later than the last Monday in April - April 25, 2022 (as required by VT statute).

Appointments are for a one-year term beginning May 1, unless you specifically request another date. The first full Maple Broadband Governing Board meeting of the new term will be Tuesday, May 3 at 5:00 pm. We are currently working remotely and holding our meetings via ZOOM. I expect that still may be the case as of May. However, sometime relatively soon we hope to be holding in person meetings at ACRPC's office at 14 Seminary St. in Middlebury. After the May 3 Annual Meeting, Maple Broadband Governing Board meetings are generally the first Wednesday of the month at 5:00 p.m. Meetings generally include updates and a business meeting, and last about 90

minutes. We ask Board members to attend 11 meetings per year. Lastly, we ask Board members to serve as liaisons between Maple Broadband and municipal officials so we can work together productively. Please continue to help us work with and for you by appointing (or reappointing) articulate and engaged citizens to the Board. Please tell new appointees that we are happy to speak with them at any time about the duties of a Board member. Please also encourage them to call me at 802-453-2681 or send an email me at nancy@maplebroadband.net to introduce themselves.

Thank you in advance for helping us keep current. If you have suggestions for improving this update process, please let me know. If you have any questions, feel free to contact either me or Maple Broadband Chair, Steve Huffaker chair@maplebroadband.net.
