Gathering ideas from the community

- Idea generation with "Focus groups" (town, business, non-profit, school)
 Follow up as needed
- 2. Invite ideas from the general public Follow up as needed
- 3. Seek feedback on collected ideas from entire community

Focus group meetings are only the very FIRST step!

Benefit of focus group

Brainstorming session, get sense of shared concerns

Keep simple, just a handful of questions

Try to get a diverse group within the segment, small group is good (8-10)

Running the group: one person asks questions; someone else takes notes

Just collecting ideas, try to note which ideas people get excited about and come up more than once

Possible Focus Group Questions

What is the biggest challenge your (business/department/organization) faces in [doing its job]?

What one or two resources would help you overcome these challenges? Why these?

What are the invisible barriers to your success that you feel most people don't understand?

If you were in charge of dispensing ARPA funds, what top two things would you spend on and why would these be the most important things?

What investments might catalyze even more growth or be more sustainable (more than the sum of its parts)?

Is there anything that we haven't discussed that you would like to share with the ARPA committee? Is there anyone not present today who you think might also give good feedback?
