

**TOWN OF BRISTOL VERMONT****Ordinance Regulating Local Enforcement of Speed Limit on State Highway**

**Article 1 Authority:** This ordinance is adopted by the Town of Bristol under authority granted by 24 V.S.A. Chapter 59, section 1971 – 1973, 23 V.S.A. 1007(f) and 13 V.S.A. 7251.

**Article 2 Purpose:** The purpose of this ordinance is to promote public safety.

**Article 3 Severability:** If any portion of this ordinance is held unconstitutional or invalid by a court of competent jurisdiction, the remainder of this ordinance shall not be affected.

**Article 4 Ordinance:** The maximum speed limit permitted for any vehicular traffic on Vermont Route 116 or Vermont Route 17 within the Town of Bristol shall be the same as those limits established and posted by the State of Vermont, to wit:

- a. Proceeding north on VT Rt 116/Rt 17 from the intersection of East Street and Rockydale Road (100 feet north of Lord's Prayer Rock) 1.1 miles, the speed limit shall be 40 MPH.
- b. Proceeding south on VT Rt 116/Rt 17 from the point designated in subsection (a) to the intersection of Rockydale Road & East Street (100 feet north of Lord's Prayer Rock), The speed limit shall be 40 MPH.
- c. Proceeding north on VT Rt 116 from the point designated in subsection (a) to the Bristol / Starksboro Town Line, the speed limit shall be 50 MPH.
- d. Proceeding south on VT Rt 116 from the Starksboro / Bristol Town Line to the point designated in subsection (a), the speed limit shall be 50 MPH.
- e. Proceeding east on VT Rt 17 from the intersection of Airport Drive to the New Haven Town Line, the speed limit shall be 40 MPH.
- f. Proceeding west on VT Rt 17 from the New Haven / Bristol Town Line to the intersection of Airport Drive, the speed limit shall be 40 MPH.
- g. Proceeding east on VT Rt 17 (north of Bristol Village) from the intersection with VT Rt 116 to the Bristol / Starksboro Town Line, the speed limit shall be 50 MPH.
- h. Proceeding west on VT Rt 17 (north of Bristol Village) from the Starksboro / Bristol Town Line to the intersection of VT Rt 116, the speed limit shall be 50 MPH.
- i. Proceeding south on VT Rt 116 (south of Bristol Village) from the intersection of VT Rt 17 to the Bristol / Middlebury Town line or intersection of Cobble Road, the speed limit shall be 50 MPH.
- j. Proceeding north on VT Rt 116 (south of Bristol Village) from the Middlebury / Bristol Town Line or intersection of Cobble Road to the intersection with VT Rt 17, the speed limit shall be 50 MPH.


**Article 5 Penalties:**


- a. This is a civil ordinance which shall be enforced in accordance with the provisions in 24 V.S.A. 1974a and 1977 et seq.

- b. The penalty for violation of any of the above speed limits shall be that set by the Schedule of Fines established by the State of Vermont.

**Article 6 Enforcement Officials:** Issuing officials shall include any officer from the Addison County Sheriffs Department, Vermont State Police and any certified Bristol Town Constable or any sworn Bristol Police Officer.

**Article 7 Effective Date:** This ordinance shall become effective 60 days after its adoption by the Bristol Selectboard. If a petition is filed under 24 V.S.A. 1973, the taking effect of this ordinance shall be governed by that statute.


