2) Letter of Support from the Regional Planning Commission – indicating that the proposed project is compatible with the Town and regional plans and the project has clear local significance for employment. YOU?

3) Letter of support from the Regional Development Corporation indicating the proposed project has a clear local significance for employment. (Document Type Supported: PDF)
