Reminder: Appointments to District Board of Supervisors

This memorandum is an annual reminder that your legislative body must appoint both a Representative and an Alternate to the Addison County Solid Waste Management District Board of Supervisors (Board), in accordance with Section 9(b) of its Charter (24 V.S.A. § 4862) regarding annual appointments following local elections at March Town Meeting. Appointments, including re-appointments of existing Board Representatives, must be in writing and signed by the appropriate official on the enclosed form. Representatives must either be a resident or an employee of the municipality they represent.

As you make your appointments or re-appointments, please carefully consider the responsibilities of Board members. The successful functioning of the Board requires the regular participation of its members. Enclosed is a summary of the attendance record for your Town's Representative in CY2022. The Board has traditionally met monthly on the third Thursday (except for the annual organizational meeting held on the second Thursday in April), currently via Zoom. However, past Boards have occasionally cancelled meetings due to a lack of new business. The Executive Board also meets monthly via Zoom, eight days prior to the Board meetings. Board members communicate regularly with their selectboards to convey the activities and decisions of the District. It is important to the long-term benefit of the District member municipalities that each has an active voice in how the Board functions and a vote on the decisions that it makes.

The Board plans to hold its annual organizational meeting via Zoom on Thursday, April 13, 2023, at 7 PM, when Elections of Officers and Executive Board members will be held. Please email or mail your signed appointment forms to Chantel Bolduc, Administrative Assistant (admin@acswmd.org), or email them to me (teri@acswmd.org) as soon as possible prior to that date.
