On the above date and time, I received an email from Katie Clark (DOB) containing an animal complaint form. The form is attached to this incident.

At approximately 1631 hours, I responded to 27 Sugar Maple Ln and upon arrival, I made contact with Katie. She came outside to show me where the incident had taken place. The following is a summary of our conversation:

- The incident took place in their back yard where they have a run for their dog and an area for their son to play. On the day the incident occurred, her dog was outside on the run and she was in the back yard with her son who was playing close by. She heard some yelling and then saw the black German Shepard come running over from 246 Morgan Horse Ln. The German Shepard headed straight for her dog and latched onto its neck. Katie picked up her son and ran over attempting to separate the dogs. Her dog was unable to flee because it was still tied up to the run. Katie managed to get the dogs separated, and the owners of the German Shepard did not come over to retrieve their dog right away. After Katie had separated the dogs herself, Tabatha) went over and took her dog and repeatedly said "I'm sorry." She walked the dog back to the house and shortly after left with the dog in her vehicle. Katie called the park manager and reported the incident to them. After the attack, Katie brought her dog to the Bristol Animal Hospital. The Veterinary medical summary/invoice is attached to the incident.

I asked Katie if she wanted to submit to have a vicious dog hearing for the German Shepard, and she said yes because that was not the first time that dog had come into her yard and she's concerned with the safety of her son.

Later in the afternoon at approximately 1833 hours, Katie and Dylan Ryan (DOB) came to the police department with their son to fill out sworn written statements describing past incidents with the German Shepard. The statements are attached to the incident.

On August 15, 2023, at approximately 1133 hours, I called the Bristol Town Office to verify if the dog was registered with the town at the time of this incident. Bristol's Town Clerk confirmed that the dog was not registered with the town at this time, but had come in on August 7, 2023 and registered.

I went to 246 Morgan Horse Ln to issue Municipal Ordinance Violation Warnings for Running at Large and License Required. Upon arrival, their neighbor was outside mowing the lawn. They stopped and told me no one was home. I put the Municipal Ordinance Violation Warnings in a plastic protective sleeve and slid it in between the door and the door frame. I took a picture of the municipal tickets on the door with my body camera.
