You are receiving this email because you have worked with CVOEO's Fair Housing Project in the past, with either of my colleagues Shiferaw or Jess. I am thrilled and honored to introduce myself as the new Striving for Equity Project Manager at CVOEO's Fair Housing Project, and to continue the work they have started through this project.

If we haven't met already, I am Corrine Yonce, and I am excited to be a part of this new project. As CVOEO's Striving for Equity Project Manager, I will be spending this next year supporting local housing committees and promoting avenues for citizen housing

advocacy. I will look to each of you and our partners across the state to identify what barriers our community members face to engaging with their regional housing advocacy efforts, and to develop community-based housing advocacy resources.
