The Planning Commission's November 24, 2023 <u>memo to the Selectboard</u> transmitting the proposed bylaw amendments provides a lot of background behind their purpose and scope.

The Vermont legislature passed several amendments and new laws this past summer affecting state, municipal, and regional planning, including the Housing Opportunities Made for Everyone (HOME) Act, Act 47 (S.100). The Vermont Department of Housing and Community Development (DHCD) issued a <u>9-page memo on June 28, 2023</u> <u>summarizing the changes</u>. Not all of the provisions of the HOME act apply to Bristol because the village does not have a municipal wastewater system.

Bristol was one of many Vermont communities who applied for and received a Bylaw Modernization grant through Agency of Commerce and Community Development (ACCD). According to the <u>ACCD Web site</u>, the program is intended "... for land use, development, and zoning bylaw updates in support of a pedestrian-oriented development pattern that increase housing choice, affordability, and opportunity in areas planned in accordance with Vermont's smart growth principles (24 V.S.A. §2791). This funding is intended to help municipalities confront the State's housing shortage and ready areas for new housing investments." Following a solicitation for proposals, the Addison County Regional Planning Commission was hired last year to assist the Planning Commission through this process.

The statutory amendments also included a provision authorizing Selectboards to vote to adopt proposed bylaw changes administratively at a regular meeting rather than putting the matter before voters, which has been Bristol's protocol. However, at its October 16, 2023 meeting, the Selectboard chose to keep the matter of bylaw adoptions with voters.

Planning Commission Chair Kevin Hanson, and perhaps others, plan to attend to provide more information and answer questions.

VII. REGULAR BUSINESS.

Item VII.1Consider Elyssa Boisselle to fill a vacancy on the Lawrence Memorial Library Board of
Trustees. Online is an e-mail from Library Trustee Chair Scott Kluever recommending
that Elyssa Boisselle be appointed to the Board to fill a second vacancy that has
emerged. The appointment would be until the March 2024 election.

RECOMMENDATION: Approval.

Item VII.2Water Commission: Continued review and possible approval of corrections to the
FY2024 Water District budget. This item is continued from the previous meeting to
circle back on the intended purpose of the new Capital Equipment Fund line item
that appears in the Water District budget status report. It turns out the \$4,989
expense posted to it was for refurbishment of a pump at the pumphouse by Pioneer
Motors. It also turns out that this was a planned expense through the Water Capital
Equipment Fund Plan.

RECOMMENDATION: Move the \$4,989 expense to the actual Capital Equipment Reserve Fund and eliminate that line from the general fund. The Capital Improvements line above it has traditionally been the line where annual allocations from the Water District budget are planned to be transferred to the Reserve Fund. - Item VII.3 Continued review of preliminary budget information (if available). This is still a work in progress. We have not received as many budget requests (that I am aware of) from outside agencies I would have expected by now. The draft FY2022 audit was received last week and I will be entering the FY2022 figures into the spreadsheet. Also still to be completed:
 - Entry of updated personnel budget data,
 - VLCT PACIF projected allocations,
 - Entry of FY2023 actuals through June 30, 2023.
 - Creation of individual department budget worksheets.

If not ready for tonight, I expect much more will be available for the next meeting.

RECOMMENDATION: Discussion.

Item VII.4Closure on the question of the December 24 holiday in the Bristol Personnel Policy.
This is a follow-up to the agenda item from last week where the Selectboard
concluded that because December 24 was specifically listed in the Personnel Policy
and falls on a Sunday this year, that it was not eligible to be carried over to a
different date. Section 22 of Bristol's Personnel Policy (2017)
provides for closing at
noon on Dec. 24, amounting to an additional four hours associated with the holiday.
Since Dec. 25 lands on a Monday this year, it was unclear at the time what happens
to Dec. 24.

Since then, we realized that the statement at the bottom of page 10 attempts to address that question: "For employees not normally scheduled to work weekends, holidays falling on a Saturday will be observed the preceding Friday. Holidays falling on a Sunday will be observed the following Monday. "However, since Dec. 24 *falls on a Sunday* and Monday is already a holiday, it still begs the question of what to do with it.

RECOMMENDATION: Allow the Dec. 24 hours to be observed on Friday, Dec. 22.

<u>Item VII.5</u> <u>Accept resignation of Firefighter Kerrin Hoff</u>. <u>Online is an e-mail</u> from Fire Chief Brett LaRose conveying Firefighter Kerrin Hoff's resignation.

Briggs Hill Road Update

The GEODesign team spent most of last week doing soil borings on the Briggs Hill Road slope, both from the top down and up from Lincoln Road.

Update from the United States Department of Agriculture Natural Resources Conservation Service (USDA-NRCS): we received notice that repair of the slope failure has <u>been deemed to be</u> <u>eligible</u> USDA-NRCS Emergency Watershed Protection funding!

EWP funds require a 25% match. It is not known yet how this funding source will affect our eligibility for FEMA funds.

Eagle Park Upate

Masterson Excavation completed most of the work at the universal fishing platform; however, some work remains to be done, including installation of the replacement rails and site restoration in the spring.

Our <u>request for an extension</u> to June 30, 2024 was supported by Vermont Emergency Management but requires final approval from FEMA.
