At A Glance

- Effective July 1, 2024, Vermont employers will be required to make contributions for a new state payroll tax for the Child Care Financial Assistance Program.
- The contribution rate is 0.44% of an employee's covered wages.
- Employers may deduct a maximum of 0.11% from employees to put toward the payroll tax.
