WHAT IS DIRECT PAY?

Thanks to the Inflation Reduction Act, the federal government will give tax-exempt entities **tax-free cash funding in the form of a refund** to build renewable energy projects.

Direct Pay will allow our communities to:

- 1. Generate **sustainable** energy that **saves money**.
- 2. Create **high-quality jobs** where we live.
- 3. Radically expand clean, **publicly-owned** energy.

 Complete projects in a way that maximizes
economic and racial justice.



HOW WILL DIRECT PAY ADVANCE JUSTICE?

IF we center projects in Black, brown, Indigenous, resource poor, and other historically excluded communities, we can...

Transfer tax-free cash funds directly to our communities.

Create good-paying, local **jobs** that build **generational wealth**.

Build **disaster-resilient** and **healthier** power generation.


Make our energy future **publicly-owned** to limit profit and exploitation in our energy economy.






Solar: utility- or small-scale rooftop, pavement, etc.




USING DIRECT PAY TO...

CALL TO ACTION AT THE LOCAL LEVEL

- 1. Implement it! States, Tribes and localities should deploy Direct Pay eligible projects and get a refund of up to 70% back from the IRS!
- 2. Spread the Word! You are trusted messengers. Make sure that everyone in your network knows about Direct Pay.
- 3. Make it Accessible! The state legislatures and City Councils can make funds available for communities who need the most help finding the upfront financing for Direct Pay projects, like creating municipal bonds, Grants, No-interest Loans, Revolving Loan Funds, and providing Technical Assistance.
