BASIS FOR DECISION:

As stated above, the parcel in question that is the subject of this Jurisdictional Opinion (JO) is located at the northeast corner of the intersection between Hewitt Road and Route 116 in Bristol, Vermont. Publicly available State of Vermont mapping tools currently depict this new ±4.70-acre parcel as originally a portion of a larger ±36.11-acre parcel, under ownership of Thomas & Pamela Lathrop.

Act 250 Land Use Permit #9A0152 was issued on November 21, 1985, to Thomas & Denise Lathrop and Claire & Ruth Lathrop, for a project generally described as construction of a ±18,000 square-foot building to house a lumber business with related site improvements. This project is located at the southeast corner of the intersection between Hewitt Road and Route 116 in Bristol, directly across the street from the ±4.70-acre parcel addressed herein. The #9A0152 Findings of Fact and Conclusions of Law and Order describes the jurisdictional parcel as follows: "The tract of land consists of 4.67± acres with 2+ acres involved in the project area."

A review of all approved site plans associated with the original #9A0152 Land Use Permit depicts this parcel and immediately surrounding lands to be all on the southern side of Hewitt Road, with no lands on the north side of Hewitt Road depicted or approved on any plans. Similarly, a review of the remainder of the #9A0152 permit file reveals that at no point was any reference made to any lands on the northern side of Hewitt Road, or to the size of the original overall parcel at that point in time.

Subsequently, Permit Amendment #9A0152-2 was issued on May 2, 2001, to Thomas Lathrop, for the purpose of incorporating ANR Water Supply and Wastewater Disposal Permit #WW-9-0398. A review of the #WW-9-0398 permit file reveals that this Permit incorporates and approves a site plan (dated 10/04/1985, last revision 01/16/2001) that depicts the original ±4.67-acre parcel under jurisdiction via Permit #9A0158. No references are made to and no lands are depicted on the northern side of Hewitt Road.

When considering this information together, it is the District Coordinator's conclusion that Land Use Permit #9A0152 was never meant to encompass any lands beyond what was immediately involved in the specifically approved project, which does not include lands on the northern side of Hewitt Road. Accordingly, it is also the Coordinator's conclusion that the ±4.70-acre parcel that is subject to this JO is not under existing Act 250 jurisdiction via Permit #9A0158 or otherwise, which therefore makes this a matter of "original jurisdiction."

As a matter of original jurisdiction, and as the project is to serve municipal purposes, this JO concludes that the project as proposed does not constitute a "development" pursuant to 10 V.S.A. § 6001(3)(A)(v) and Act 250 Rule 2(C)(5)(b), therefore an Act 250 permit is not required.

Any party may file within 30 days from the date of a decision of the District Coordinator a request for reconsideration with respect to the jurisdictional opinion, pursuant to Act 250 Rule 3(B). Any reply to a request for reconsideration shall be filed within 15 days of the service of the request, unless otherwise provided by the District Coordinator.

Any person aggrieved by an act or decision of a District Commission or District Coordinator, or any party by right, may appeal to the Environmental Division of Vermont Superior Court within 30 days of the act or decision pursuant to 10 V.S.A. § 8504. Such appeals are governed by Rule 5 of the Vermont Rules for Environmental Court Proceedings. The appellant must file a notice of appeal with the clerk of the court and pay any fee required under 32 V.S.A. § 1431.

The appellant must also serve a copy of the Notice of Appeal on the Natural Resources Board and on other parties in accordance with Rule 5(b)(4)(B) of the Vermont Rules for Environmental Court Proceedings.
