I am writing with a request for your municipality to reappoint **2 designees** for the Addison County Regional Emergency Management Committee at one of your upcoming Select Board meetings and sign and return the REMC Appointment Form by June.

Regional Emergency Management Committees (REMCs) coordinate and support regional all-hazards emergency planning and preparedness activities to improve each region's ability to prepare for, respond to, and recover from all disasters. The Addison County Regional Planning Commission provides administrative support to the Addison County REMC (https://acrpc.org/acrpc-remc/).

The Addison County REMC consists of two voting members from each municipality:

- The local Emergency Management Director or Emergency Management Coordinator, and
- A representative of the local emergency services community

Important: If one of the representatives is unable to attend meetings, they may designate the other as the voting member in their city or town to serve as their proxy (by checking the box next to their name). This proxy designation allows that individual to represent 2 individuals for the purposes of achieving quorum. We recommend checking boxes by both names so that either representative can represent the other in the case that they aren't present at the meeting.

The Addison County REMC also encourages public or private individuals or organizations interested in emergency planning and preparedness to attend as non-voting members.

The next meeting of our Regional Emergency Management Committee will take place on **May 8 (noon-1pm)**, and additional meetings are held on the second Wednesdays of August, November, and February. Please do not hesitate to reach out to me if you have questions or wish to discuss further.
