VTrans is pleased to announce that we are now accepting grant applications for the SFY 2025 Transportation Alternatives Program (TAP) and the Municipal Highway and Stormwater Mitigation Program (MHSMP) grant opportunities concurrently. This year over \$4.3 million of TAP grant funding is available for all eligible activities as described in the Vermont Transportation Alternatives Application Guide included in the link below. Approximately 50% of TAP grant program funds are reserved for pollution mitigation projects relating to stormwater and highways, including eligible salt and sand shed projects. Also, approximately \$1.5 million of MHSMP grant funding is available for eligible stormwater pollution mitigation projects as described in the Municipal Highway and Stormwater Mitigation Program Guide which can be found in the MHSMP link below.
