- **Seth Hill property:** a conversation with David Brynn about land in Lincoln (that Bristol owns used to be water source for the town of Bristol). 120 acres on Downingsville Road. - Parks Updates (Aiden Lenihan): New signs ordered for parks; did work on the playground on town green; Japanese knotweed cut back along trails to river at Sycamore Park (will burn cut knotweed in the parking lot of Sycamore Park). The removable railings on the fishing platform at Eagle Park have been installed; railings will be removed in winter and replaced in late spring.
- Accessible Design for Town Parks: concept designs have been sent discussed them briefly. Sycamore Park: concern about proposed paved trail and paved parking lot potential damage during flooding. The paved path and parking lot at Eagle would make more sense because it doesn't flood.
