I'm writing to ask for permission from the town of Bristol to use certain roadways during a cycling event known as the **Vermont Gran Fondo scheduled for Saturday, June 28th, 2025**. Bristol is one of 22 towns through which ~450 cyclists will pass over an eight-hour timeframe. As event organizers, the Vermont Department of Public Safety requires us to gain permission from each town and notify each town's police/sheriff department and EMS/ambulance service.

We will sign roadways and busy intersections to ensure the safety of event participants and caution/notify residents and motorists of the event and that there will be riders on the road. We will utilize support from local sheriff departments Vermont State Police, and VT Flaggers to manage significant intersections.

We will obtain insurance coverage for the event, and I will give the town a copy of the certificate of insurance showing proof of coverage.

The event will start and finish at the Bristol Rec Field at 110 Airport Dr. Brsitol, Vermont. There are four different courses: ~39 mi(Piccolo), ~80 mi (Medio), ~109 mi (Gran), and ~145 mi (Gran-X). Cyclists depart Bristol between the hours of 6 a.m. and 10 a.m. Information on each route can be found on the event website at <u>http://vermontgranfondo.com/explore-the-course/</u>.

Depart:

- Start on Liberty St, turning left onto West St/ Rt 17(controlled)
- Through Bristol center
- Right to Lincoln Road, heading into Lincoln

Return:

- to Bristol via Route 17 from New Haven
- Turn left onto Burpee Rd at the Rt 17/116 intersection
- Turn right onto Plank Rd

- Turn right onto North St
- Turn right onto Pine St
- Turn left onto Liberty St
- Turn right onto West St
- Turn right onto Airport Dr. Finish.

Gran-X Return :

- arrive from Lower Notch Rd & South St
- Turn left onto West St
- Through Bristol Center
- Right onto Liberty St. to Finish

If you need more information, please let me know.

Your earliest response would be greatly appreciated, as it would allow me time to complete state-level permissions.
